Your impact upon our work

Dean's Introduction

Welcome to our 2013-2015 Donor Report. I am delighted to have the opportunity to thank you all for your generosity and support.

The last 2 years have seen a lot of change. We have weathered it well and continue to go from strength to strength. We are now ranked in the top 18 business schools in Europe (top 4 in the UK) and have ambitions to make it to the top 10 in the next five years. We have invested in upgrading and expanding our physical resources – opening a fantastic new facility at 200 Aldersgate Street for our Executive Education business and our Executive MBA; refurbishing the MBA syndicate rooms and lounge at Bunhill Row; and also refurbishing the home of the Undergraduate Programme at Northampton Square and this includes improved space for students to network and work in groups. We have continued to invest in our world class faculty and have welcomed a further group of outstanding teachers and researchers to Cass over the last 2 years.

In terms of students, the main growth area has been our Undergraduate Programme, which has grown by over 60% in the last five years and we

have plans for further modest growth over the next few years. Last year, we received the results from the Research Excellence Framework (REF) and these attest to the strength and depth of Cass research. According to the REF 2014 results, 84% of Cass research was rated as world-leading (4^*) or internationally excellent (3^*) : the top 2 categories. This places Cass in the top 6 in the UK, out of 101 institutions. These REFtype exercises take place every 6 or 7 years and this is the best result that the business school has ever achieved. The outcome of this independent review highlights the global standing of Cass and the world class quality of Cass research, and recognises the impact that our research has on business, the professions and policymakers. This is very important for Cass students and our corporate clients because it means that the academics, who teach them and supervise their work, are pre-eminent in their fields and indeed are making great contributions in advancing these fields.

As you may already have heard, I will be stepping down as Dean in November. Our new Dean, Marianne Lewis, joins us as Dean-elect this month and I hope many of you will have the opportunity to meet her at our upcoming donor events. You can read more about Marianne on page 18 of this Report.



Building business relationships



The past two years have been exciting for corporate development. Leading insurance company Generali joined us last year, and April this year saw us enter into a Corporate Partnership with Tullett Prebon Information (TPI), a leading global provider of financial market data. The aim of the partnership is to collaborate on research into comparative regulation of over-thecounter (OTC) markets, which will then be made available to the wider industry. Students electing to conduct research into aspects of the OTC markets will have access to TPI's proprietary data and its support teams.

We are also pleased to have extended our partnership with Columbia Threadneedle Investments to allow the launch of the Columbia Threadneedle Executives' Undergraduate Scholarship. A flying start

Today's students face one of the most competitive graduate job markets the UK has seen and almost all students at Cass will need to call upon the services of the Career and Professional Development Team for assistance. Thanks to support from the Cass Fund, the Careers Service at Cass has been able to expand the services on offer, reflecting the changing nature of the job market. This includes new workshops, webinars and coaching opportunities, as well as the creation of career focussed e-learning modules.

The Cass Fund also supports scholarships for the School's budding entrepreneurs, helping to get their businesses off the ground.

Individual donations have supported a major enhancement of our facilities with 26 new computer spaces and 46 new study spaces at Bunhill Row and a state of the art Financial Resources Suite in Northampton Square. Leading Change in the charity sector

The Centre for Charity Effectiveness

Charity is now accepted as the third sector of the economic world. With a global economic force greater than that of many small nations, the study and effective management of nonprofit organisations has become essential

The Centre for Charity Effectiveness at Cass Business School (known as Cass CCE) was set up to become the leading not-for-profit and philanthropy centre in the UK. It is a centre of excellence where academics, management consultants and other not-for-profit experts pool their understanding of the voluntary and community sector.

The Centre's mission is to drive transformation. It's work has significantly enhanced the performance of hundreds of organisations and thousands of individuals across the nonprofit sector.

The Centre has just celebrated its tenth anniversary of the Centre. Since its launch in 2004 through a partnership between the School and the Worshipful Company of Management Consultants, CCE has become the focus for MSc and Voluntary Sector Management programmes with over 1,000 graduates worldwide. Alumni of the Centre now lead some of the UK's most successful charities with many returning to further their professional development through original, specialist leadership courses. In addition, the immensely popular Charity Talks series has attracted over 10.000 attendees with new open programmes, events and services being introduced every year.

The Centre has been supported and recognised by external funders. In 2007, a Big Lottery grant of £2 million was received for the development of the e-learning portal, KnowHow NonProfit, followed in 2008 by an ESRC grant of £2.2 million to establish the Centre for Charitable Giving and Philanthropy.

The Centre's consultants have worked with charities of all sizes to improve effectiveness. They have delivered over 700 assignments, published guides including 'CEOs first 100 days (ACEVO') and 'Tools for Tomorrow (NCVO)'. They have also generated thought leadership through the publication of major papers including 'How to become a Third Sector CEO', 'Delivering Effective Governance' and 'Bridging the Gap moving onto nonprofit boards'.

More recently the Centre launched the first ever Lord Mayor's Charity Leadership programme, bringing together Chairs, CEOs, funders and leading supporters of charities from the City for lectures and networking events to promote better understanding and engagement within Europe's financial capital.

For 2015, a new social investment and impact service has been launched to help nonprofits maximise the funding opportunities in the social investment, demonstrating a commitment to future ground breaking collaborations.

Welcoming Professor Marianne W Lewis

Professor Marianne W Lewis joins Cass as the new Dean in November 2015 from her current roles of Professor of Management and Associate Dean at Carl H. Lindner College of Business at the University of Cincinnati.

Drawing on her 20 years' experience in international business research and education Professor Lewis will lead Cass Business School and become a member of the University's Executive Committee.

Professor Lewis graduated in Business Administration from Tusculum College, Tennessee in 1989, completing her MBA in 1991 at Indiana University. She obtained her PhD in Management from the University of Kentucky in 1997 and joined the Faculty at the University of Cincinnati shortly after. She was a visiting Fellow at Keele University in 2000 and as a US-UK Fulbright Scholar spent time at Cass in 2014.

Professor Lewis' research considers management and organisational behaviour as well as innovation and entrepreneurship. In 2000, her paper, 'Exploring paradox: Toward a more comprehensive guide' received the Academy of Management Review Best Paper Award. Her work has appeared in other leading journals, such as the

Academy of Management Journal, Organization Science, Journal of Operations Management and Human Relations.

"I am most looking forward to building partnerships – within Cass, across City University London, within the London community and across an international network: partnerships that can harness the potential of Cass Business School. As a Fulbright Scholar here not only did I meet the tremendous Cass faculty, but I saw the power of Cass in London as an intellectual hub, engaging researchers from the UK, as well as across the EU and North America. My subsequent visits confirmed that this pattern of passionate researchers and committed supporters reached beyond Cass into City University London and outwards to *alumni* and external partners."




Cass Business School
